RESPECTIVE FUNCTIONS OF THE BOARD OF GOVERNORS AND PRINCIPAL IN RELATION TO ADMISSIONS

The Board of Governors will determine the Admissions Criteria. The criteria will be applied by the Principal and a Sub-Committee of the Board of Governors.

The Principal will consider the acceptance of each pupil to the school within the confines of the published criteria for admission, but any decisions will be subject to the ultimate approval of the Board of Governors. St. Bernard's Primary School and Nursery Unit in the parish of St. Mary's on the Hill.

The following criteria have been established and will be implemented by the Principal and the Board of Governors Admissions Panel.

When considering which children should be selected for admission, the Board of Governors will only take into account information which is detailed on the application or provided directly to the school. Parents/Guardians should therefore ensure that all information pertaining to their child and relevant to the school's admissions criteria is stated on the application or provided directly to the first preference school via the Education Authority's Admission Portal. Examples of such information include whether the child has brothers/sisters attending the school.

ADMISSIONS CRITERIA

During the admissions procedure when applying the criteria, <u>punctual applications</u> will be considered before <u>late applications</u> are considered. The application procedure opens on Friday 10th January 2025 at 12 noon (GMT) and an application submitted by the closing date of Friday 24th January 2025 at 12 noon (GMT) will be treated as a <u>punctual application</u>. An application received after 12 noon (GMT) on Friday 24th January 2025 and up to 4 pm on Wednesday 29th January 2025 will be treated as a <u>late application</u>. This is also the <u>last date and time for processing a change of preference in exceptional circumstances</u>. After 4 pm on Wednesday 29th January 2025 no applications will be processed until after the close of procedure on Wednesday 9th April 2025.

COMPULSORY SCHOOL AGE

Any child who reaches their 4th Birthday on or before 1st July 2025 is of Compulsory School Age. Under the School Age (NI) Act which became law in Northern Ireland in April 2022, 'compulsory school age' also includes those children who deferred commencing Primary 1 in September 2024 as defined by the new School Age (NI) Act (both groups to be treated equally).

Priority will be given to children resident in Northern Ireland at the time of their proposed admission to the school before those who are not so resident.

The following criteria will be applied in the order set down 1 - 6 by the Board of Governors of St. Bernard's Primary School. Only children of compulsory school age will be considered. (See above)

1. Children of compulsory school age who reside in the Parish of St. Mary's on the Hill and who have a sibling defined as 'a child of the family' (see below) at time of application attending St. Bernard's Primary School i.e. any year group from Nursery to Primary 7 inclusive. (Indicate name and year group).

- 2. Children of compulsory school age who have a sibling (see below) attending St Bernard's Primary School i.e. any year group from Nursery to Primary 7 inclusive and who now live outside the Parish of St. Mary's on the Hill. (Indicate name and year group).
- 3. Children of compulsory school age who attend St. Bernard's Nursery Unit or St. Bernard's Playgroup, Glengormley.
- 4. Children of compulsory school age who reside in the Parish of St. Mary's on the Hill.
- 5. Children of compulsory school age who are a 'Child Looked After' as defined by the Children NI Order 1995 as children who are in the care of a Trust or who are provided with accommodation by the Trust.
- 6. Children of compulsory school age from outside the Parish of St. Mary's on the Hill.

Note: Siblings/A child of the family includes brothers, sisters, half-brothers, half-sisters, children who are adopted, fostered and children of either party from a previous marriage/relationship.

Sub-Criteria

If over-subscribed in any one of the above criteria taken in order, final selection will be on the following tiebreaking method.

(a) Pupils will be selected for admission on the basis of the initial letter of their surname (as entered on the birth certificate) in the order set out below:

K Y Q G B A L Z D H F O M V S Mac I U Mc N R T E J W P C X

This order was determined by a randomised selection of letters carried out by Governors on 12/11/24. In the event of surnames beginning with the same initial letter the subsequent letters of the surname will be used in alphabetical order. In the event of two identical surnames the alphabetical order of the letters of the forenames will be used to determine selection. The first name will be used in the case of a double-barrelled surname. Surname must be as entered on the birth certificate only.

(b) If it is still not possible to distinguish between applicants, places will be allocated by a computerised randomised selection. (Audits will be kept)

Please note, applications for primary school places should be completed online through the Education Authority's admissions portal. The portal will open for parents to complete an online application on Friday 10th January 2025 at 12noon (GMT). The closing date for the receipt of punctual applications is Friday 24th January 2025 at 12noon. Documentation submitted in support of your application e.g. your child's birth certificate, address verification etc. must be uploaded via the online portal not later than 4pm on Wednesday 29th January 2025.

DUTY TO VERIFY

The Board of Governors reserves the right to require such supplementary evidence as it may determine to support or verify information on any application. If the requested evidence is not provided to the Board of Governors by the deadline given, this will result in the withdrawal of an offer of a place. Similarly, if information is supplied which appears to be false or misleading in any material way, the offer of a place will be withdrawn.

Parents should note that the deadline for providing new information for inclusion on their child's application is Wednesday 29th January 2025 no later than 4pm.

Applicants should note that where an address contained within an application qualifies it for admission, then that address will have to be verified. This is in addition to the standard requirement to provide a Birth Certificate in order to demonstrate whether or not a child is of compulsory school age.

Updated November 2024

If supplementary evidence is requested, original documents are required and not photocopies. Original documents can be returned on request at the end of the admissions process by the primary school to which the child has been admitted. Applicants preferring not to put verifying documents in the post or seeking alternative verifying arrangements should contact those primary schools listed on their application form that require verifying documents to agree alternative verification arrangements.

WAITING LIST POLICY

Applications for admission to Primary 1 for September 2025 before the start of the school year:

Confirmation advising parents of the primary school in which their child has been placed/not placed will be issued via the EA Connect Portal on Wednesday 9th April 2025. After this date, all applications for admission to Primary 1 which were initially refused, late applications, applications where new information has been provided and new applications received will be treated equally and the criteria as listed above will be applied. Your child's name will be added to this list automatically and, if a place becomes available, the school will contact you in writing. This waiting list will be in place until 31st August 2025. Parents must inform the school in writing if they wish to have their child's name added to a new waiting list which will take effect from 1st September 2025. Should parents wish to have their child's name retained on the waiting list indefinitely, they must inform the school of that in writing at the start of each subsequent new school year i.e. 2025, 2026, 2027 etc.

Applications for places in Primary 1 after the start of the school year i.e. from 1st September 2025:

If a vacancy arises, and provided no class in Primary 1 exceeds 30 pupils, the Principal and Board of Governors deem it is in the best interests of all involved and the efficient use of resources is not prejudiced, the Admissions Criteria will be applied to select pupils from the waiting list. It is the parents' responsibility to inform the school in writing that they wish to have their child's name added to the waiting list.

ADMISSION TO Primary 2 – Primary 7

Pupils will be admitted to Primary 2 – Primary 7 in accordance with the preference of their parents provided their admission does not lead to the enrolment number being exceeded. The Principal and Board of Governors deem it is in the best interests of all involved and the efficient use of resources is not prejudiced. In the event of over-subscription, the same admissions criteria will be applied as for admission to Primary 1.
